
The Neopuff Infant T-Piece Resuscitator is a manually operated, gas-powered resuscitator designed to provide breaths at a set flow with consistent Peak Inspiratory Pressure (PIP) and Positive End Expiratory Pressure (PEEP) to infants.





Optimal Resuscitation

Current resuscitation guidelines recommend the use of a T-Piece device with the potential benefits of achieving controlled target PIP and delivering consistent PEEP to help establish Functional Residual Capacity (FRC) and improve lung volume.



Easy to Use

The experience, training, concentration and fatigue level of the operator do not affect the pressures delivered.

Flexibility in Operation

The Neopuff can accept and deliver oxygen concentrations from 21% to 100% coming from a flow meter or a blender. The T-Piece Circuit can connect to infant resuscitation masks or endotracheal tubes.

Accurate Pressure Delivery


The fast-acting manometer provides constant reassurance of mask seal and delivered PIP and PEEP.
